

# **Health & Safety Training for Child Care Providers**

# Requirements and Overview of Health & **Safety Trainings**

California law\* requires providers in child care centers and family child care homes to complete 16 hours of training about health and safety. Training includes Pediatric First Aid and Pediatric Cardiopulmonary Resuscitation (CPR) and Preventive Health and Safety practices. Preventive Health and Safety training includes instruction on infectious illnesses, including immunization requirements, preventing childhood injuries, safe sleep practices, caring for children with special needs, identification and reporting of child abuse, lead poisoning prevention, and childhood nutrition.

- The 1 hour of nutrition curriculum has been included since January 1, 2016, and lead poisoning prevention curriculum was included as of July 1, 2020. Both are required components of an approved Preventative Health and Safety training.
- On and after January 1, 2026, persons shall obtain training in a pediatric first aid or pediatric CPR course that includes instruction in the prevention and treatment of anaphylaxis, including the emergency use of epinephrine auto-injectors.

At least one director or teacher at each center site and all family child care licensees must complete the required 16 hours of California Child Care training, including family child care co-licensees. If a licensee with the full training is absent any time when children are onsite or offsite for facility activities, at least one additional person with current certification in Pediatric First Aid and CPR must be present. Preventative Health and Safety training is not required for family child care assistants or volunteers.

Providers must submit copies of course completion cards, training certificates, and/or transcripts to the Community Care Licensing office and keep a copy on file at their center or child care home. Licensing staff will check these documents, including expiration dates, at the time of your site visits. For more information, call Community Care Licensing at (916) 651-6040.

## **Resources for Health & Safety Training**

Child Action does not endorse or recommend any trainer or training companies. Be aware that not all CPR/First Aid trainings will meet requirements set forth by Community Care Licensing. This handout contains a list of approved health and safety training resources. Ask about fees, refund policies, and proof of registration. All trainees will receive an approved certificate upon completion that includes the number of hours attended.

# Providers must be certified by one of the following approved training programs:

- 1. A training program approved by the Emergency Medical Services Authority (EMSA)
- 2. The American Red Cross
- 3. The American Heart Association
- 4. A course or training program offered or approved by an accredited college or university

# California Child Care Preventive Health and Safety Training

Preventative Health and Safety trainings must be taken through an EMSA-approved program. Courses that use a virtual classroom setting that allow for live interaction with the instructor are allowed as outlined by EMSA.
