- Applicants are eligible for only one rebate per year.
- The health & safety rebates are funded on an annual basis. There are NO GUARANTEES that you will be reimbursed. Rebate amounts may vary from year to year and are contingent upon the availability of funds and allocated on a first come, first served basis.
